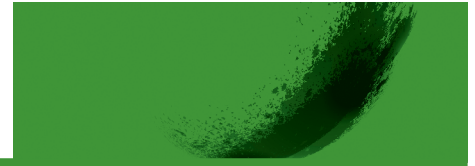

Kresto kwik-wipes® are made from polypropylene and are moistened with a cleansing solution. Thanks to its slightly rough structure, the wipe features consistent and reliable cleansing power without the use of abrasive additives. Kresto kwik-wipes® clean quickly and thoroughly, without unduly stressing the skin.

Area of Application

For fast cleansing and pre-cleansing after contact with heavy-duty contamination such as waste mineral and lubricating oils, graphite, metallic dust and carbon black. For workplaces where there is no water available for cleaning hands. Ideal for drivers, breakdown services, assembly and maintenance personnel, workmen etc.

- no water necessary for rinsing
- do not use on face
